RECERTIFICATION

The ABAA is committed to promoting life-long continual improvement for those who have earned accreditation status. **The certification maintenance requirements mandate a minimum of 15 hours in ABAA-approved Medical Education Courses in Animal Acupuncture or animal medicine, or instruction in animal acupuncture, and a recertification fee of \$200.00.** Credentialed Diplomats are ultimately responsible for ensuring the timely submission of their Certification updates. In order to receive important communications, including newsletters and policy updates, it is imperative that ABAA be kept informed of your current address information.

GRACE PERIOD

There is a 90-day grace period after your current certification documentation and recertification fees are due. Your certification will be considered lapsed, beginning on the 91st day after your required due date if you have not submitted both the required MEUs and recertification fee.

ABAA RECERTIFICATION APPLICATION

Recertification requires a total of 20 hours, every 4 years, of approved continuing education courses in animal acupuncture and/or animal medicine and/or teaching.
